

Appalachian Mountain Club – Berkshire Chapter Executive Committee  
Minutes of Meeting – September, 18 2006

Meeting was called to order at 6:38 pm.

**Acceptance of Minutes:**

Minutes of the August 21, 2006 meeting were read, amended, and accepted unanimously.

**Treasurer's Report:**

Kelly Druzisky reports that we have about \$18,000 cash on hand. She's requested a \$7500 check from the Porter Dickenson fund payable to Noble View Camp.

**Committee reports:**

Appalachian Trail: Cosmo Catalano

Cosmo reported that the AT Committee met on 9/11/06. Jim Pelletier will serve as Vice-Chair of the AT Committee, and will coordinate duties with Cosmo as Cosmo transitions into academic leave status.

A committee member is donating foodstuffs for the AT day festivities. Cosmo needs two leaders for AT day hikes; Nappy may have a substitute.

Cosmo reports that power tools and chainsaws have been stolen from the tool shed at the Mt. Greylock Visitors Center. The value of the loss is \$5000 - \$6000. The theft has been reported to the State Police.

The AMC regional office has a contractors toolbox that Cosmo will relocate to the tool shed.

A logging operation is proceeding in October Mountain State Forest, and is supervised by a State Forester in accordance with the green logging practices required by the Forest Reserves program and processes. A local individual, Carl Rosenstein, has protested this proposed logging, and has sent a package of information to Faith Salter at Joy Street.

The AT Committee plans to replace the Wilbur Clearing Shelter in Spring, 2007.
