NOTES:

4. Scheduled club trips have priority on rental boats. Private use (AMC members only) limited to QW or Class 2.
5. Non-AMC scheduled Raft Trips are limited to Fife Brook Trips guided by an AMC leader.

POLICY OF LIABILITY FOR BERKSHIRE CHAPTER CANOE & KAYAK COMMITTEE EQUIPMENT

The renter is liable for replacement or repair costs up to a maximum of _ the current depreciated value of the boat or equipment, a value to be reassessed by the canoe committee Equipment Coordinator. The extent of liability up to the maximum will be determined by the Equipment Coordinator after consideration of details of the incident. In case of the loss of a boat, the Berkshire Chapter Canoe & Kayak Committee will approve the liability assessed.
